ON-GOING FORMATION CORNER

MEANS AND INSTRUMENTS OF ONGOING FORMATION

Ongoing formation is the privileged vehicle of transmitting charismatic elements and consolidating the personal identity of a missionary of faith. Exactly one year ago, began the detailed discussion of ongoing formation in this column. During this period, we have seen different elements such as, *project and its content, general principles and methods* of ongoing formation. In the present issue I would like to present the concept of *means and instruments* of it, thus concluding with its formal aspects.

Means and instruments are *the content carriers to the formee*, to put it concisely. They are the material and immaterial elements selected to communicate the content of the project of ongoing formation to the persons in question. It requires careful selection, attentive planning and passionate execution to be efficient and productive. Failure to do so has seen many well-prepared projects remaining only on paper or merely at theoretic level. It can be said that the end result depends largely upon the efficiency of means. However, the organic nature of the project is not to be overlooked by giving precedence to only one aspect. Let us now get to the concept of means and instruments of formation.

Concept of means and instruments of formation

The Oxford dictionary gives the meaning of the word as "an action or system by which a result is achieved". It is used in a wide variety of contexts to denote the activity of attaining a desired result. Applied this to the formative activity it can well mean an action or a system by which the projected formative result is achieved. "Dizionario di Scienze dell'educazione" proposes that "means" could refer to the teaching aids, the didactic materials as well as the class room materials or didactic equipments. In pedagogy, special attention is paid in the selection of right means and instruments, taking into account various elements - discussed in the previous issues - and making the formative process interesting and innovative. A book as well as a computer, the blackboard as well as the video projector, could be considered as means or instruments, because they help in communicating the formative or educative content to the formee. If so, then the action of the body and the spoken word could also be considered as

means, because formees tend to imitate the formators. Hence, sometimes a means could also be a method. The word "means" could very well refer to wide spectrum of elements. Any medium that communicates the formative contents to formees, is considered "means or instruments" of formation.

Types of means or instruments

There are a wide variety of things and resources that could be considered as means and instruments. It can be confusing sometimes whether something is a method or a means. The fact is, sometimes a means could also be a method, as is passingly mentioned earlier. There are many types of means. They are often classified differently by different authors. I would like to make three classifications, because I intend to clarify the point than to give an exhaustive list of them. Each Major Organism of our congregation, having its own specific nature, can surely adopt the appropriate means so as to achieve the projected goal of the project.

1. Body as a means: It can be said to be the first means of instruction. The primitive societies, before the invention of writing and script, used body as a means of instruction. The gestures or the voice could very well communicate to the student what the master wanted to teach. Thus, survival tactics and traditions were taught to the next generation. The formees, on their part, observe the gestures or listen to the voice of the master. Imitating them was an effective means of formation. Even today, despite the modern inventions, the gestures and voice of the formator is an important means of instruction. It is enough to see the resistance of the parents to the e-learning practices during this pandemic, to understand the influence of direct instruction even today. In the ongoing formation of the priests too it can be a very valid element. It is for this reason that there are a lot of retreat houses, centers for ongoing formation etc. They confirm that physical presentation and direct contact have a better impact.

The magisterial teaching⁴ as well as our General Order of Formation⁵ proposes *personal* accompaniment as a means of formation. In proximity or at distance, the presence of a person is presumed. So, a formator should remember to present oneself decently and formatively at all times. He should not neglect to give appropriate care to his body, of course, without exaggerations. Just like a well-prepared dish is served out on a decorated plate, a well-prepared formator should dish out his knowledge with decorum and elegance. Presentation matters! Being exemplary is pedagogically and spiritually valid as it is the visual means for the formees to imitate.

- 2. *Materials as means:* Books, visual aids, writing materials, technical instruments etc., used for formational practices can come under this category. Books could be given a preferential slot in this hierarchy because they eternalise ideas and ideals. They also last longer. Discoveries of papyrus, clay tablets etc. by historians have revealed valuable knowledge about the past civilizations. Graphical and pictorial instruments are continuously evolving. Today we have computers and internet as portals of knowledge at-fingertips! The correct use of them is formative, while the incorrect, excessive use of them may lead to pathological or unethical behavior. A formator should try to acquire the appropriate knowledge and mastery of them. This would maximise its formative utility and efficiency.
- 3. Scientific means: Invention of various instruments like lens, telescope, microscope etc. changed the school system forever. The postmodern society can boast of gadgets and technologies that are much more sophisticated and advanced. They are used in different ambits of research for deepening the understanding. In this sense, for an astronomer a telescope is not just an instrument, but a means of learning; for a physician microscope is not just an instrument, but a means of learning; for a psychologist, observation is a means of learning; an evaluation questionnaire that a

formator uses, is not just an instrument, but a precious learning tool. Instruction is not anymore solely learning to read, write or calculate. It is much more sophisticated and profound. Research methods (remember that a method could also be a means) like experiments, observation etc. are inevitable today. Today we use a wide variety of scientific means for instruction and evaluation in formation. It is also a reminder to the formator that he is not completely autonomous or unanswerable. Means of evaluation need to be simple so as to avoid unnecessary fear and confusion 9

Rapport between objectives and means

A systematic reflection of means 10 makes it clear that objectives, methods and means must go hand-inhand. 11 The selection of a means is to correspond with the projected objective. One cannot choose the book of mathematics to teach religion or a manual of initial formation for the ongoing formation of a confrere with alcohol addiction; a discourse on charity is not the appropriate instrument for a priest with the problem of sexual abuse. It may be said that the integral nature and efficiency of a formative project could be verified by analysing the quality of rapport between objective and goal.

A formator should be capable of distinguishing the categories of means in a systematic and organic way. Whatever is helpful in attaining the objective is a means or an instrument. There could be natural (ambience) or artificial (equipment like instruments, library, computers, blackboard). 12 The application of the natural instrument of ambience, for example, could be found in Vita Consecrata in the recommendation of having formation in a formative community. 13 The clarity of the objective or goal is vital in selecting the correct means and instruments of formation. A formator should constantly bear in mind that means are all those elements that have to do with communicating the formative content to the formees at the operational level. But the efficiency of these depends also upon the response of the formees to them. Even the best means and instruments could result useless if they are not appealing or understandable to the formees.¹⁴ Hence, due consideration must be given to the rapport between the objective and means.

Conclusion

The term *means* denotes *an action or a system* put into use for achieving a projected objective or goal. Means in a project of formation are, those elements chosen to communicate its content to the formees. They are the *content carriers*. There are different types of means like material or scientific means. Body, gestures or the spoken word of the formator could be means. Equally considerable are the didactic instruments and materials or even the ambience of the formation house. Then there are also the scientific means of research and evaluation. Care must be taken in selecting the means and instruments, keeping in mind the need of rapport between objectives and means. Such carefully chosen means and instruments will surely render the programming and execution of a projected itinerary of formation efficient and productive.




Perpetual Profession of Bro. Arun Kumar Lawrence
